There will be no Ambassador Contest.

Entry fees must accompany entry blank; in no case will fees be waived or refunded.

The first events will be all of the Pole Bending & Goat Tying in south arena and all of the Breakaway Roping, Ribbon Roping, Calf Roping & Flag Race in the north arena.**

You will be called only twice for an event. Be ready.

Contestants will pay when they come through the gate.
