#### REGISTRATION-7:00 TO 8:30 a.m.

Contestant must wear their numbers in a visible spot while competing. Contestant meeting at **8:30 a.m.** in the large arena. Rodeo starts at **9:00 a.m.** 

Contestants will be called 3 times before they are disqualified and passed by. Order of events is subject to change.

If a contestant is entered in a Jr.Jr. event they can not enter a Junior event. Ex: If they enter Jr.Jr. barrels, they can not enter Jr. poles. Ex: Junior contestants cannot enter into senior events.

# Pennington County 4-H Rodeo COVID-19 Guidelines

### We are asking that all spectators and contestants follow the guidelines:

If you are not comfortable attending the event, **PLEASE** do not come!

If you are not feeling well or are feeling sick, we ask that you **DO NOT** attend the rodeo.

**PLEASE** allow distancing when parking.

A charge of \$5.00 is being added as a separate line item on each entry form for the gate entrance fee. This will eliminate the need for gate personnel to collect money upon entrance to the facility.

Check in will be done when entering facility. Please remain in your vehicle, and tell the checkin personnel the names of contestants checking in, as well as any events they are drawing out of.

A food vendor truck will be on-site to provide food, rather than the traditional youth-run concession stand. Please practice social distancing while ordering/waiting for food.

Face masks are recommended in all areas and will be provided upon request at the entrance gate. Face masks are required in the arena zone unless state standards are relaxed by event date. Contestants can pull down masks while performing.

Please limit attendees to immediate family of contestants.

Practice social distancing at all times and in the seating areas, as per CDC recommendations

Contestants, **DO NOT** congregate by any of the arena gates, or on the Bucking Chutes.

For the flag race, multiple sets of flags will be rotated and sanitized between use.

An appropriate number of volunteers will be staffed according to the number of contestants entered. Volunteers should remain in their designated role/location throughout the day.

Rough Stock and Timed Event will be allowed NO MORE than 2 helpers.

Hand sanitizing stations will be distributed throughout the area.

Bathrooms and surfaces will be sanitized on a scheduled basis.

The rodeo committee will have the right to ask anyone to leave the grounds that is not complying with any of the guidelines put into place.

Thank you for your patience and understanding. If you are not comfortable, PLEASE do not attend.
