The meeting was Called to Order by President Treg Cowan.

Treg asked for the Reading and Approval of Secretary Minutes for 2024 annual meeting. Teri Henninger made a motion to dispense with the minutes and to approve. Joy Meyer second the motion. Motion carried.

#1 Add: Animals must be flanked for all rough stock events. Teri Henninger made motion to discuss, Mandy Healy second the motion. Motion carried. Discussion was held.

Casey Bachand made motion to approve the additional wording. Teri Henninger second the motion. Motion carried.

#2 Change team roping in both Jr & Sr divisions to be 2 loops and a 30 second time limit. Discussion followed. Brenda Ries made motion to approve this change. Dena Fulton 2nd the motion. Motion carried with 2 rodeos voting No.

#3 Change entry dates back one month. Kim Larson, finals rodeo secretary, commented on the mail situation and the timing to get entries completed prior to the start of rodeo season. Mandy Healy made motion to approve. Elke King 2^{nd} the motion. Motion carried.

#4 Change number of qualifying contestants at regional rodeos from 4 per event to 3 per event. Discussion was held in length. Roll call vote was taken. 9 rodeos voted in favor of changing, 13 voted no. Motion failed.

Treg asked for suggestions on how to resolve the size of the finals and the parking issues. Lots of discussion followed.

2026 Rodeo Dates were requested. Several rodeos provided their 2026 rodeo dates. Please get your 2026 rodeo dates to Kathy Monnens, Lay Board secretary as soon as possible.

Election of 2026 Lay Board Officers was presented. Terri Henninger nominated Treg Cowan for President, Penny Heenan 2nd the nomination. Motion carried.

Teri Henninger nominated Bryce Chamblis as Vice President. Rusty Heenan 2nd the nomination. Motion carried.

Teri Henninger nominated Kathy Monnens as Secretary/Treasurer. Penny Heenan 2nd the nomination. Motion carried.

Teri Henninger nominated Joy Meyer as Director At Large. Penny Heenan 2nd the nomination. Motion carried.

Brandon Spencer is the Director at Large as Representative of SD 4-H Finals Board

Proposed Rule Changes

1. Current Rule under Rodeo Livestock Passed

Stock contractors may be required to have enough stock for a go-round in each event, the amount of stock to be based on the number of contestants the previous year, plus a percent, the percent being the cut to even up the stock. Any stock declared by the sponsoring group as unsatisfactory must be replaced. If a re-ride is given for an animal 4 times in a row, that animal will automatically be declared unsatisfactory and must be replaced. Untried or green rodeo stock will not be permitted.

ADD the follow to the current rule

Stock contractors may be required to have enough stock for a go-round in each event, the amount of stock to be based on the number of contestants the previous year, plus a percent, the percent being the cut to even up the stock. Any stock declared by the sponsoring group as unsatisfactory must be replaced. Animals must be flanked for all rough stock events. If a re-ride is given for an animal 4 times in a row, that animal will automatically be declared unsatisfactory and must be replaced. Untired or green rodeo stock will not be permitted.

Rationale – This addition clarifies that flanking is required for all rough stock animals, not optional. It maintains fairness by ensuring consistency in competition and reaffirms that a reride will be awarded if the flank comes off during performance.

Also propose to change: Late Entries postmarked after May 1^{st} through June 1^{st} will be assessed a \$150 fee .

TO Late Entries postmarked after April 1st through May 1st will be assessed a \$150 fee.

Also propose to change No entries will be accepted after the June 1 deadline.

TO No entries will be accepted after the May 1 deadline.

4. CHANGE FOR QUALIFYING FOR FINALS Failed

Over 50% of contestants qualified for the finals. To make the finals more competitive I propose to change the qualifying metrics from top 4 in a regional rodeo to top 3 in a regional rodeo.
