SD 4-H Finals Rodeo Committee, Inc. Minutes of January 17, 2015

The January 17, 2015 meeting was called to order by Vice President Don Bergeson. The Pledge of Allegiance and 4-H Pledge were recited.

Terri Heninger made a motion to dispense of the reading of the October 25, 2014 meeting minutes and approve them as written. Russell Maier 2nd. Motion carried.

Treasurers Report:

Teri Heninger reported the checking account balance at \$26,697.47 and the Money Market at \$1,014.50. Total of \$27,711.97 in checkings/savings. Expenses since the last meeting include the scholarships, SD Dept. of Corrections, flowers for Jimmi Cable's funeral and postage for the 2015 Sponsorship mailing. Since the last meeting we have received \$8,630.00 of which \$2,800.00 was money for 2014 Regional Rodeo sponsorships and \$1,500.00 from the Fort Pierre Economic Development Corp. Russell Maier made a motion to approve the Treasurer's Report. Deanna Smith 2nd. Motion carried.

Old Business:

The Finals Rodeo Committee extends a huge "Thank You" to Teri Heninger and Vicki Heninger for donating their time to the Advertising/Sponsorship Committee. Teri will provide an Excel spreadsheet with a list of businesses that are currently getting a Sponsorship Letter. (see attached) After reviewing the list if there are businesses you feel should be added to the list as potential sponsors, please pass the information on to Teri Heninger.

New Business:

Vice President, Don Bergeson read both the current and proposed By-Law:

The Current By-Law: C. The terms of officers elected at the annual meeting shall commence at the adjournment of that meeting and shall serve until adjournment of the next annual meeting. Terms of the officers will be three years. The President and Treasurer shall end their terms on odd years. The Vice President and Secretary shall end their terms on even years. No officer would serve more than two consecutive terms.

Proposed By-Law: C. The terms of officers elected at the annual meeting shall commence at the adjournment of that meeting and shall serve until adjournment of the next annual meeting. Terms of the officers will be two years. The Vice President position will be a President-Elect Position; the Vice President will serve a two year term and automatically move into the President Position for a two year term. The term of Treasurer shall end on odd years. The Vice President and Secretary shall end their terms on even years. No officer would serve more than two consecutive terms.

Kathy Monnens made a motion to approve the Proposed By-Law C. Julie Maude 2nd. All members present In Favor. Motion passed.

Saddle Sponsorship Fee:

The current Sponsor Fee for a saddle is \$700.00 or \$350.00 for half a saddle. There are 25 saddles awarded at the 4H Finals Rodeo. Saddle costs for 2014 were \$880.00 with the exception of the Steer Wrestling Saddle which was \$930.00. This price does not include shipping. Diana Melvin made a motion to bring the following to a vote at the **October 2015 Annual Rodeo Committee Meeting**. Increase the Saddle Sponsorship cost to \$800.00 /saddle or \$400.00 /half saddle for private sponsors only. (not to include the Regional Rodeos) **This motion would affect the 2016 sponsorships**. Julie Maude 2nd. All in favor. Motion carried.
