ZIEBACH COUNTY 4-H RODEO GENERAL RULES

The 4-H Rodeo Committee encourages both parents to fully read the published rules, which apply to contestants and all events during this show. No deviations or exceptions can be made. We encourage you to obtain and read the State 4-H Rodeo Rules and Regulations (YD4H 414). These are available at your county extension office or the 4-H Website at <http://www.sd4hrodeo.org/>

Buckles will be awarded each day for the events. There will be NO average and NO All Around prizes given, (except for the Jr. Jr. Events).

After reading these general rules, we call your attention to the specific rules which apply to individual events. The committee reserves the right to cancel any event due to lack of contestant participation.

1. Eligibility: The 4-H Rodeo is open to a 4-H member in good standing.
2. Entries: **Entries will close on the 6th of July 2020.** We require that the fee must accompany each entry. This can be cash, check, or money order, made payable to the **ZIEBACH COUNTY 4-H LEADERS ASSOCIATION.**
3. You will only be called twice per event. Have all equipment ready before the event.
4. There will be "No Video review" made available to the judges or arena personnel to assist in making a judgment call.
5. The decision of the judges, flagmen, timers and arbitration board who have been approved by the sponsoring rodeo board shall be final and no further protest by contestants will be allowed.
6. If using 1 horse in more than one age division, please inform the secretary when you check in of this fact.
7. All contestants must be in western attire when receiving awards.
8. **State Finals Rodeo Entry** - The State Finals paperwork entry deadline is May 1st. Contestants are responsible for reading and following the General Information on Finals Entry Forms and the Ground Rules pertaining to the 4-H Finals Rodeo. All contestants qualifying for the 4-H Finals Rodeo (by finishing in the top 4 places at a Regional/County 4H Rodeo) are automatically entered. If a contestant does not wish to enter the finals, or has event/events that they wish to not enter, they will have to notify the Finals secretary via email (4HFinalsSecretary@gmail.com) and mail a paper copy by AUGUST 1ST. If the contestant does not notify the secretary prior to the finals draw, the contestant is responsible for the entry fees. NOTES TO PARENTS:

CHECK YOUR CHILD'S ENTRY FOR COMPLETE DETAILS. MAKE CERTAIN EVENTS ENTERED ARE ONLY THOSE OF WHICH YOU APPROVE.

GATE ENTRY FEE: There will be a two-day pass for the weekend if attending both days. The cost is \$12.00 for adults and \$8.00 for school age children. The one-day pass will be \$7.00 for adults and \$5.00 for school age children. You will be given a wrist bracelet for the weekend pass. School age is considered age 6 & up. Children 5 and under are free.

Ziebach County 4-H Rodeo COVID-19 Guidelines

We are asking that all spectators and contestants follow the guidelines:

If you are not comfortable attending the event, **PLEASE** do not come!

We are encouraging only immediate family attend.

If you are not feeling well or are feeling sick, we ask that you **DO NOT** attend the rodeo.

PLEASE allow distancing when parking.

Check in will be done when entering gate. Please remain in your vehicle and tell the check-in personnel the names of contestants checking in, as well as any events they are drawing out of.

Practice social distancing while ordering/waiting for food at concession stand.

Face masks are recommended in all areas. Face masks are required in the arena area unless state standards are relaxed by event date. Contestants can pull down masks while performing.

Practice social distancing at all times and in the seating areas, as per CDC recommendations

Contestants **DO NOT** congregate by any of the arena gates, or on the Bucking Chutes.

For the flag race, a glove will be required to be worn by the contestant.

The crows nest area will be limited to personnel only, contestants must check in at the rodeo grounds entrance gate.

An appropriate number of volunteers will be staffed according to the number of contestants entered. Volunteers should remain in their designated role/location throughout the day.

Rough Stock will be allowed **NO MORE** than **2** helpers.

Hand sanitizing stations will be distributed throughout the area.

Bathrooms and surfaces will be sanitized on a scheduled basis.

The rodeo committee will have the right to ask anyone to leave the grounds that is not complying with any of the guidelines put into place.

Thank you for your patience and understanding. If you are not comfortable, PLEASE do not attend.

COVID-19 RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of the above-named member ("Member") being allowed to participate and compete in the Ziebach County 4-H Rodeo on July 18 & 19, 2020 in Dupree, SD, we, the Member, and the undersigned parent(s) or legal guardian of the Member, on behalf of the Member, and for ourselves, our personal representatives, heirs, spouse, parents, siblings, and children, do hereby:

1. RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Ziebach County 4-H Rodeo, South Dakota 4-H Rodeo, SDSU, host facility owners, any rodeo committee, any stock contractor, any rodeo or event sponsors, or any other entity associated with the Ziebach County 4-H Rodeo, and each of them and their officers, directors, trustees, managers, agents and employees (all of whom are collectively referred to herein as "Releasees") from any and all liability to the Member, the undersigned, and their personal representatives, assigns, heirs, parents, legal guardians, siblings, and children, and any claims or demands therefore, on account of the Member's or the undersigned's injury, illness, disease or death from the COVID-19 coronavirus, which occurs as a result of the Member's or any of the undersigned's entrance onto the Ziebach County 4-H Rodeo and/or participation as a contestant, assistant, official or otherwise in any rodeo event, whether such injury, sickness, disease or death is caused by the negligence or other wrongful conduct of, strict liability or otherwise by, one or more of the Releasees or any contestants, spectators or other individuals at the rodeo arena in which the rodeo is held.
2. AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from any liability, damage or loss (including, but not limited to, attorneys' fees and other defense costs) one or more of them may suffer or incur arising out of or related to the Member's or any of the undersigned's entry onto the Ziebach County 4-H Rodeo and/or participation in any rodeo events, whether such claim is based on one or more of the Releasees' negligence, breach of contract or warranty, strict liability or other legal theory
3. UNDERSTAND that Member's and the undersigned's entry onto the grounds of the Ziebach County 4-H Rodeo and/or participation in rodeo events during the COVID-19 pandemic contains DANGER AND RISK OF ILLNESS, DISEASE, INJURY OR DEATH TO MEMBER and the undersigned, that COVID-19 is highly contagious, and that there is INHERENT DANGER in COVID-19 which the Member and each of the undersigned appreciate and voluntarily assume because we choose to do so. WE EACH VOLUNTARILY ELECT TO ASSUME AND ACCEPT ALL RISKS inherent in COVID-19.
4. We each agree to comply with all federal, state and local laws and regulations and all security policies and procedures of the Ziebach County 4-H Rodeo relating to COVID-19. We each understand that the Member may be denied entrance to the Ziebach County 4-H Rodeo and not allowed to participate or continue to participate in the rodeo based on medical check-in requirements and continuing medical requirements during the duration of the rodeo. The undersigned agree that in the event any portion of this document is held to be invalid, the balance shall, notwithstanding, continue in full legal force and effect to the greatest extent possible under applicable law. The parents or guardian of the Member agree that by signing below they are in addition to binding themselves, binding the Member to the maximum extent permitted by applicable law.

WE HAVE READ THIS RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE, AND INTEND THIS TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY APPLICABLE LAW.
