## 2017 4H Finals Rodeo:

- Rodeo Manager: Mike Stieger -There will be a meeting for judges and timers before the first performance of the Finals Rodeo in 2017. Judges and timers pay will remain the same as 2016.
- Ambassador Committee: Reported by Brittney Hunsley –Morgan Janisch, 2016 Ambassador along with members of the 4H Finals Rodeo Ambassador Committee visited the SD Legislature representing SD 4H Rodeo on February 8th. She had the opportunity to meet both Governor Daugaard and Lt. Governor Michels. Morgan and members of the Ambassador Committee will be visiting local hotels in Pierre/Ft Pierre on aster Monday April 10th.
- Rodeo Announcers: Justin Stampe and Allen Odden roughstock/track arena. Keith Gebhart Barrel/Pole arena.
- Saddles: Roger Theobald –9 saddles have been ordered
- Heather Schoultz, Finals Rodeo Secretary: Entries are coming in slowly. The first listing of 2017 4H Rodeo Eligible Contestants is ready to post. This will be updated weekly until May 1<sup>st</sup>.

## **Additional Business:**

Heather Schoultz brought up the need for a Team Roping clarification statement in the SD 4H Finals Rodeo Ground rules regarding what happens when an entered team roper is injured and unable to compete. Discussion regarding the option for the team roping partner that is uninjured will be clarified and added to the Ground rules for 2017.

NSF checks at regional rodeos was discussed. Currently the 4H Finals Rodeo has no approved rules/regulations regarding collection of NSF funds written at regional rodeos.

The SDHSAA has moved up the date of the first high school football games in 2017 by 1 week. This will move them to August 18<sup>th</sup> which is also the first performance of the 4H Finals Rodeo in 2017. The SD 4H Finals Rodeo board has asked to be on the agenda for the next SDHSAA meeting April 18<sup>th</sup> and will report back at our next meeting.
