# **Meeting Minutes**

# Teleconference, March 24<sup>th</sup> 2021

**Call Meeting to Order:** Tyson Paxton called the meeting to order via teleconference on March 24<sup>th</sup>, 2021 at 8pm CST.

**Secretary's Report:** Motion was made by Pauline Witte to dispense the reading of the Secretary's minutes from the January 26<sup>th</sup> meeting. Kathy seconded the motion. Motion carried.

Treasurer's Report: Unavailable.

#### **Old Business:**

- Panels: Don Bergeson gave a brief update on panels. He has contacted couple dealers but at the time of the meeting had not received any prices or quotes.
- COVID Update: John Keimig updated the group in regards to SDSU's current status/level on COVID. John told the group that SDSU is using a color system and it is currently on color Orange. This means that SDSU has lessened its policies and restrictions somewhat. John reports that if they get to level Green the regional rodeos would not need to provide a waiver. John will let us know at the beginning of May. He recommends that the region rodeos hold off on sending any letters/waivers as the COVID restrictions may be lifted.
- Rodeo Schedule: Only two rodeos had given their dates. Those were Penington Co. which is to be held on May 29<sup>th</sup>, 2021 and Dewey Co. on May 30<sup>th</sup> 2021. A new rodeo is being considered by the Sioux Area 4-H Rodeo committee.
- Expo Center: Helen Jane Paxton—no updates.
- Special Needs Rodeo: It was agreed that if COVID restrictions were lessened, we should have the Special Needs Rodeo. Diana Melvin agreed to make some calls to local schools and agencies to see if there is interest. We are looking for a volunteer to be in charge of lining up the Special Needs Rodeo, again, if it is decided to have it.

## **New Business:**

 2021 4-H eligible list and entry update: Kim Larson reported there currently are 318 approved forms and 21 that had problems that need to be corrected before they could be approved. Kim reported that it seemed like she was having to return less than she did last year.

- Grant Updates: Sue Van Liere reported that she had completed the application process for a grant from the Ft. Pierre Tourism board but had not yet heard if it had been granted. Sue also reported that Helen Jane did find out we were awarded a \$20,000 grant from the COVID relief program.
- Stock Bid Committee recommendations: This committee met on Monday March 22<sup>nd</sup>. Their recommendations are:

- 50<sup>th</sup> Anniversary Committee: No updates. Don asked about inviting Governor Noem to be a part of one of the Grand Entries. Treg mentioned having a Military Recognition night.
- Honorees: It was asked that we start thinking about who we will give special recognition to this year. If you would like to nominate someone, please notify one of the board members. It was also discussed that we need a running list of who has been recognized in the past.

Rodeo Manager: Tyson Paxton—It was decided that each region rodeo will again be asked to volunteer to work an event. If the region rodeos don't pick an event or area to work, they will be assigned a job.

Rodeo Timers/Judges: Tyson Paxton. Teri Heninger is going to help line up timers.

Grounds: Donnie Bergeson and Jeremy Cass—Don reported that when he last talked to Jeremy, Jeremy is willing to help work arenas again this year.

Ambulance: Helen Jane—The contract has been sent to AMR.

BBQ: Regina Maier—No updates. Waiting to see what restrictions might be in place at that time.

Buckles: Kathy Monnens—Kathy received a bid from Tres Rios. The buckles will be \$100/buckle and Tres Rios is going to sponsor 20 buckles!

Saddles: Teri Heninger—Teri was not on the call but according to Don reported that Triple R will be who we get the saddles from. We will be awarding Scott Thomas saddles this year. Don also reported that we currently have 6 new saddle sponsors.
