

# **SD 4-H FINALS RODEO, INC. MEETING MINUTES**

## **MAY 1, 2019—Conference Call**

**Call to Order:** President Kasey Hanson called the meeting to order.

**Approval of Secretary Minutes:** Tyson Paxton made a motion to approve the March 10, 2019 minutes. Pauline Witte second. Motion carried.

**Treasurer's Report:** Helen Jane reported the checking account balance is currently \$62,097.00. Donnie made a motion to approve the treasurer's report. Second by Kim. Motion carried.

### **Old Business:**

- Regional rodeo entry forms are due to Kathy Monnens. Haakon/Jackson, SCSD, Sioux Empire, and Sisseton still need to get theirs in as soon as possible.
- Kim Larson gave a report on the current entries. As of May 1<sup>st</sup>, she has received 873 entries.
- Discussion then took place regarding vendor space both below the grandstands and in the Expo Center. It was decided to offer past vendors their spot under the grandstands for \$250. Vendor spots in the Expo Center will be \$90. If previous vendors would rather have their booth at the Expo Center, then it will be first come first served for spots under the grandstand. **Rodeo Order of Events:** It was decided to move the flag race back to the rough stock arena. This should help so the east arena can finish sooner.
